The RG1 portfolio returned +6.6% in January², with the long book contributing +7.4%, and shorts detracting -0.8% in a very strong month for global equities.

The largest contributors for the portfolio in January were holdings across the resource industry. Notably, the performance was broad based, with gold, copper, coal and uranium miners all contributing positively. Tightening supply markets and a lower USD have been tailwinds for our resources holdings recently.

The portfolio's holdings in Korean semiconductor stocks were also positive contributors for the month as the memory chip shortage intensified and boosted earnings. We have continued to trim these positions into strength.

Detractors for the month included positions in the online gaming sector, which have suffered from the perception they will lose share from prediction market platforms. We continue to believe these fears are overblown, albeit are difficult to disprove in the short term, and we have been adding tacitly to our positions during the sell-off.

While shorts on the whole were a detractor, we had positive contribution from short positions in expensive, high growth consumer internet stocks where we believe consensus is fundamentally overestimating the sustainability of current earnings power.

Buy-back: In January, approximately 1.4m RG1 shares were bought at an average price of \$2.43.

Dividend: The recently announced 6.0c fully franked dividend for RG1's 1H26 financial results has an ex-date of 18 February and is payable on 23 March.

Accordingly, the RG1 Board will determine future dividends taking into account the quantum of realised gains and available franking credits.

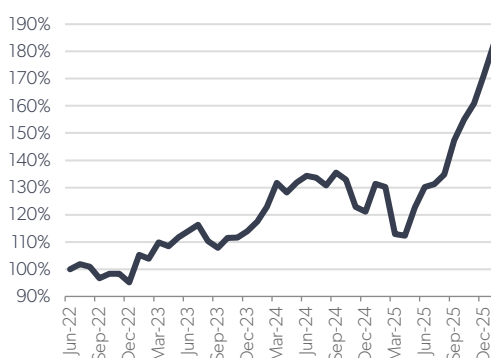
